

**REGULATIONS FOR THE PREPARATION OF DOGS FOR EXHIBITION F (ANNEX B)**

1. The Regulations must be observed when the dog is prepared for exhibition and/or exhibited at any Kennel Club licensed event. Objections may be referred to the General Committee for disciplinary action under the show regulations and /or for disciplinary action under Kennel Club rule A 11.
    - (a) A dog found to have been exhibited in breach of these regulations will automatically be disqualified from exhibition at the show and from any award gained thereat.
    - (b) Unless similar provides a satisfactory explanation for the dog being exhibited in breach of these regulations then he/she may be subject to further penalties of either a fine or as listed under Rule A 42
  2. No substance which alters the natural colour, texture or body of the coat may be present in the dogs coat for any purpose at any time during the Show.
    - (a) No substance which alters the natural colour of any external part of the dog may be present on the dog or any purpose at any time during the show.
    - (b) Any other substance (other than water), which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat or any other part of the dog at the time of exhibition.
  3. No act Corp, which alters natural confirmation of a dog or any part thereof, may be performed except:
    - (a) Operations certified to the satisfaction of the general committee.
    - (b) The removal of any dew claws of any breed.
    - (c) Operations to prevent breeding provided that such operations are notified to the Kennel Club before neutered dogs are shown.
- Nor must anything be done, calculated in the opinion of the general committee to deceive.**
4. The General Committee without previous notice may order an examination of any dog or dogs at any Show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the Kennel Club in their possession. Samples may be taken for further examination and analysis.
  5. Any individual has the right to lodge an objection to a dog only if he/ she is the owner or handler of a dog competing in the same breed or class. An objection may, however, be lodged by an official of the Show or by anyone, so deputed by the Kennel Club. It will be the responsibility of the individual who lodges the objection or the official (as appropriate) to substantiate the grounds for the objection. The Kennel Club will substantiate the grounds for an objection made on its behalf.
  6. Any objections by an individual related to an infringement of these Regulations must be made in writing to the Show Secretary at his/her office before the close of the Show and the individual must produce evidence of identity at the time of lodging the complaint.

**WARNING Your dog is vulnerable and at risk if left in a vehicle in high temperatures and even on days considered slightly warm. Please take care of your dog. If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused.**

I/we further declare that I believe to the best of my knowledge that the dogs are not liable to disqualification under Kennel Club Show Regulations.
