On no account will entries be accepted without fees. If a dog is in the process of Registration or Transfer at the time the entry is made, add the letters NAF or TAF as appropriate after its name. Please put classes in numerical order and use BLOCK CAPITALS throughout when completing this entry form. The Kennel Club Authority to Compete Number (for dogs registered and resident outside of the U.K.) must be stated or the entry form will be returned. PLEASE CHECK ALL DETAILS BEFORE POSTING.
